### ***OUR CHILDREN FIRST – HELPING PARENTS FOCUS ON THEIR CHILDREN AS THEIR FAMILIES ARE BEING RESTRUCTURED***

This workshop is designed to highlight key areas important for parents to focus on with their children during the time their families are being restructured due to separation and divorce. The latest research on the impact of divorce on children will be discussed, as well as the steps which can be taken to ameliorate the negative consequences and increase the likelihood children will navigate their new families successfully.

**Talia Eisenstein, Psy.D.** has been a practicing psychologist for the past thirty years. She received her doctorate from Hahnemann University in 1981. Dr. Eisenstein is the Director of the “Our Children First” program, a Montgomery County Court mandated parent education program designed to teach parents how to co-parent after divorce. This program has been used as a model for programs established in a number of counties in Pennsylvania. Dr. Eisenstein’s practice includes individual therapy (adults, adolescents, and children); couples and sex therapy; pre- and post-divorce co-parent counseling.
