ETHICS, ELECTRONIC COMMUNICATIONS AND PROFESSIONAL PRACTICE

New ethical issues are emerging in this rapidly changing environment of electronic communication and telehealth. However, specific standards do not exist to address these dilemmas. Knowing how to respond to these challenges requires a unique approach to ethical decision making grounded in the overarching ethical principles. This workshop will focus on the ways in which electronic communication, telehealth, and social media promote or prevent client welfare. Case examples will be presented, and participants are encouraged to share their own ethical dilemmas.

Linda K. Knauss, Ph.D., ABPP is a Professor at Widener University's Institute for Graduate Clinical Psychology and the former Director of Internship Training there. Dr. Knauss is the Past-chair of the American Psychological Association's Ethics Committee, the American Board of Professional Psychology's Ethics Committee, the Pennsylvania Psychological Association's Ethics Committee, and has served as Co-chair of the Philadelphia Society of Clinical Psychologists' Ethics Committee. Dr. Knauss taught courses in ethics at Widener University, Immaculata University, and the Philadelphia College of Osteopathic Medicine. She has authored several book chapters and journal articles on ethics and has taught many continuing education workshops on a variety of ethical issues. Dr. Knauss was the recipient of the 2002 Ethics Educators Award presented by the Pennsylvania Psychological Association's Ethics Committee. In addition to her work at Widener University, Dr. Knauss maintains a private clinical practice where she sees children, adolescents, adults, and families.
